WHAT IS THIS INVESTMENT VEHICLE?

OBJECTIVES	The management style offers balanced exposure to equity markets and alternative products (up to 65% of the portfolio managed) and more secure investments such as interest rate products and monetary assets. Alternative investments* are limited to instruments, the change in value of which is negatively or very weakly correlated to the change in values of other components of the portfolio. No direct or indirect opportunities for investment in private capital (private equity), risk capital or unlisted shares are offered. The recommended investment horizon is at least 4 years.
INTENDED RETAIL INVESTOR	This investment vehicle is intended for policyholders who wish to control the risk associated with their savings in the medium term. They therefore consider an even distribution between moderately secure assets and risky assets.
