INCLUSION OF ETFS IN THE CARDIF LUX VIE RANGE OF EXTERNAL FUNDS

Dear Partner,

As we develop our offering in relation to unit-linked investment vehicles, Cardif Lux Vie is pleased to announce that it is now possible to integrate ETFs into any of the proposed life insurance policy vehicles and into our range of External Funds in particular.

ETFs (Exchange Traded Funds, also referred to as trackers) are financial instruments listed on the stock exchange that track or replicate the performance of a stock market index, without being actively managed. Integrating ETFs into a life insurance product opens up scope for a greater diversification of the portfolio assets, while benefiting from reduced financial management costs compared to those of traditional External Funds.

The investment themes are very broad and many ETFs promote values that are dear to us, namely better integration of ESG criteria as well as strong commitments in favor of energy and ecological transition.

Their eligibility criteria, as well as liquidity, will be analysed in relation to each vehicle (External Funds, Internal Dedicated Fund, Specialised Insurance Fund or Internal Collective Fund).

To be included in the Company's **External Funds Catalogue**, the ETFs must also meet the following additional conditions:

- Daily listing;
- Assets of more than 1 billion;
- Capitalising security.

The proposed listed ETFs in this catalogue will be valued on the basis of the closing price on the Valuation Date.
